These are appeals from an October 21, 1991, decision of the Muskogee Area Director, Bureau of Indian Affairs, assessing additional royalty under Osage oil and gas leases.

On April 27, 1991, appellants in Docket No. IBIA 92-41-A, Charles L. Jenkins, d.b.a. Jenkins Drilling Co., and Evelyn Simmons, Personal Representative of the Estate of Mildred B. Jenkins, filed a motion seeking to have their individual appeal dismissed and to be added as appellants in Melvin E. Acott v. Muskogee Area Director, Docket No. IBIA 92-95-A.

For good cause appearing in the motion, the request is granted. Pursuant to the authority delegated to the Board of Indian Appeals by the Secretary of the Interior, 43 CFR 4.1, Docket No. IBIA 92-41-A is dismissed, and Charles L. Jenkins, d.b.a. Jenkins Drilling Co., and Evelyn Simmons, Personal Representative of the Estate of Mildred B. Jenkins, are added as appellants in Docket No. IBIA 92-95A.
